### **SCHOOL COUNCIL FUNDS**

There are only 3 months left to spend your School Council's annually allocated funds before the school year ends.



School Councils are issued government funds annually to operate and to promote Parent Engagement. TDSB School Councils receive annually \$500 (Parent Engagement) + \$1.25 per full-time student (council admin funds) from the Ministry of Education, through the TDSB.

Depending on the size of your school, that's \$800 to \$1500! Many schools have still not spent their annual allotments. This money does NOT carry over to next year. **School Council funds must be spent by June 30.** 

There's still time! Bring the conversation to your School Council about <u>how you can use this money</u> to benefit your school community.

### PRO GRANTS UPDATE



TDSB has received an allocation of \$253,125.14 for the 21/22 school year for projects that demonstrate a commitment to respecting the role of parents/caregivers in students' educational experiences. This year's allocation supported an array of initiatives including:

- School Council Anti-Black, Anti-Indigenous, and Oppression Grant (\$170,000)
- Parents Caregivers as Partners Conference (\$10,000+15,000=25,000)
- Virtual Engagement Tools (\$13,125.14 + 10,000-reallocation =\$23,125)
- Central Administrative Expenses (\$25,000.00)

School Councils continue to roll out their PRO projects. See this year's <u>list of approved applicants.</u>
